# FROM TOM'S MEMOIRS

#### KONTIKI

One of the exciting events in which I participated with the Single - Dial transmitter was the Kontiki expedition that Thor Hyerdahl launched in the fall of 1946. That was the experiment in the



balsa raft to prove that the ocean currents would carry him and his crew from Peru across the Pacific to the western islands. He took along amateur equipment to keep in contact with "home". I was a part of the group of hams who listened for his transmissions and carried his news to the rest of the world.

My job was to get up certain mornings at four a.m. to look for him on the radio. I had the pleasure of contacting him the day that he first sighted land. He didn't land, but allowed a couple of his crew to set out in a small boat they had aboard to paddle ashore. The two men got ashore all right, exchanged greetings with the "natives". They decided to take the men back to the raft in a canoe, but by the time things got organized, the raft had drifted to the west of the island and there was a mad scramble to catch up. They brought supplies with them that were very much appreciated by the Kontiki group. Hyerdahl sent me a summary of all that, which I phoned to the local newspaper. A couple of days later I heard the landing they made at the end of the trip, but I was not able to contact them with my transmitter. Conditions were not suitable that morning

#### Court Room

In May 1945, I received a call from an attorney who asked me if I would testify in a case in which his client was suing an insurance company. The client, had set the furnace for a house temperature of 55 degrees and gone to Florida for several winter months. While he was away, the furnace failed to operate and the water in the radiators froze and burst some of the radiators. The flying metal parts had done considerable damage and when the weather moderated, the ice in the remains of the radiators melted and did more damage.

The insurance company had insured him against explosion but they maintained this was not an explosion. The attorney asked me to testify as a physicist that it was an explosion and to show how to prove it. I agreed and began to make preparations.

We did a demonstration in the Physic II course to show the explosive power of freezing water. We had a steel ball about 4 inches in diameter with a 1/4 inch thick wall and hollow inside. There was a threaded hole about an inch in diameter in the

surface of the ball. A threaded  $\frac{1}{4}$  inch thick plug could be screwed into the hole to seal the opening.

First remove the plug, heat some water to boil away any air dissolved in it, then let the water cool to room temperature. Fill the ball absolutely as full as possible, screw the plug in tight, to be sure there is no air pocket inside the ball. Then put the ball into a steel pail filled with a mixture of water, ice and salt. This produces a solution that is a degree or two below 32 degrees and sit back and wait, usually 20 to 30 minutes. When the water in the ball freezes, a very large force is developed by the ice trying to expand. The force becomes so great that even this steel ball blows apart with a rather impressive noise.

I arrived at the court room with my prepared pail, with a cover, and the ball. I put them on the witness stand and sat down.

"What is all that for?' asked he judge.

"This is going to be a demonstration of an explosion". I put the ball in the water and replaced the lid. The lid was to enhance the effect and to be sure no pieces would fly up and out.

The usual proceedings got under way and "my" attorney asked what I had there. I explained.

"Will it make much noise?" he asked.

"Oh, you bet," I replied. Then things went on with questions and answers.

After about ten minutes, the judge said, "Bailiff, take that bucket out of here, I can't stand the suspense!" The bailiff took it out in the hall and came back.

Another ten or so minutes went by and there was a very loud bang from out in the hall.

"Bailiff, go see what happened and bring the thing back in."

The lid had jumped off and there was a large dent in the side of the pail. Everyone was quite impressed.

During the performance, the attorney for the insurance company asked me all sorts of questions. He was so inept that I was getting a kick out of it. He asked me, "What is the tenstil strength of water?"

"I don't know the meaning of that word, tenstil."

"You mean to tell me a supposed authority in physics doesn't know what tenstil means!" My attorney looked it up in the dictionary and said there was no such word. Did he mean tensile? The jury laughed.

At another point he said to me, "Are you trying to testify as an expert in physics and you are blind?"

I replied, "So far as we have been able to ascertain, blindness has nothing to do with mental acuity!" To this, the judge said, "Bravo, bravo!" And the jury laughed some more.

The client won the case and was compensated for the damage to his house and furnishings.

That was a lot of fun.

My father, W5JHJ, unexpectedly became a Silent Key on July 21 this year. He had been a member of the OOTC for only a few years, though he had been eligible much longer. He was also a member of the QCWA. Health problems kept him from being very active in the club or on the air these past few years, though he always wanted to be more active. I know that he particularly valued his membership in the OOTC.

My Dad was born on 28 September, 1922. He became a ham around 1938-1939 or so (I don't have the exact date, yet) during the Depression, as part of training he received in a National Youth Administration camp (which was part of the WPA). W5JHJ is his original-issue call.

He used that training to obtain his 1st Class Radiotelephone ticket and became the chief engineer at the old KOME AM station in Tulsa and then in his military duty as a stateside LORAN slave station operator on Padre Is., long before it had become a tourist attraction. After leaving the military, he returned to being a broadcast engineer before earning his BS and then MS in physics at the University of Tulsa. He then became an aerospace engineer at AVCO Tulsa Division until AVCO closed that facility. Afterwards, he ran a small business, Electronic Systems, out of his home until his failing sight forced him to reluctantly close the business.

He taught me radio theory and CW, and then he and a friend of his proctored my Novice exam in 1970, where I earned the call WN5CLC. I have remained active ever since. While I was in Colorado, from 1982-1995, we kept a weekly schedule on 40 m 'fone. After I returned to Oklahoma in 1995, that schedule, and his activity, fell by the wayside. I will certainly miss him very much.

#### THE DEATH OF NEW YORK'S RADIO ROW BY SYD STEINHARDT

THE BATTLE

The Radio Row merchants steeled themselves for the titanic battle to come. In 1959, they formed the Downtown West Businessmen's Association (DWBA). Its original purpose, ironically, was to promote their area as Electronic City with the enthusiastic support of Rockefeller's DLMA. As the site of the proposed World Trade Center complex moved across town, the association's mission became that of preserving Radio Row by defeating the redevelopment plans.

Led by Oscar Nadel of Oscar's Radio Shop at 63 Cortlandt St., the DWBA fought the condemnation proceedings until they exhausted all legal avenues in July 1966. Along the way, they engaged in street theater that caught the attention of the local and national media. They carted coffins down Cortlandt Street to demonstrate the death of the small businessman. Their families demonstrated outside Gov. Rockefeller's New York Cit office. In January 1964, they traipsed up to New Hampshire to heckle Rockefeller as he campaigned for the Republican presidential nomination.

Despite the legal defeats and the public indifference, Nadel refused to surrender. When the PA offered a bonus of three months' rent to those stores that

moved out by Feb. 28, 1966, 32 business owners accepted the buyout. One of them was the DWBA's executive director, Barry Ray. His Bal Tea and Coffee Shop was unfortunately located in one of the Hudson & Manhattan Terminal Buildings, two of the first properties that the Port Authority took over and demolished. "They've knocked out 32 of us, but we still have nearly 200 left." a defiant Nadel told The New York Times the next day. "If they want to evict us, let them try it."

It was already too late. With the backing of the courts, the governors and legislatures of New York and New Jersey, an unaccountable public authority, and the Manhattan commercial interests, the World Trade Center was an accomplished fact. The demolitions started on March 26, 1966. By then, the remnants of Radio Row had been dispersed so successfully that the Port Authority could justifiably claim that a new Radio Row was developing on West 45th Street.

Over 300 businesses, employing 30,000 people and directly providing the livelihood for as many as 120,000 more, were destroyed.

"They never had a chance," said Ronnie Nadel.

#### THE AFTERMATH OF THE BATTLE

Many of the merchants closed shop, never to reopen. Some relocated. Others went to work for someone else, while others simply retired. "A lot of them passed away from the stress," said MacInnes.

Simonoff believes that Oscar Nadel was one of them. "Oscar died a broken man," he said. "There were a lot of broken men."

Morton Brody is one of those who had to relocate. His store, Morel Electronics, stood at 185 Washington St. since 1950. "Some (merchants) went over to Chambers Street," he said. "I ended up on West Broadway." There he remained until he retired in 1982. His wife and partner, Jacqueline, died in 1998. Now 80 and in ill health, Brody is still bitter about the Port Authority. "They threw out private enterprise," he said.

Public entities replaced it. In January 1964, receiving no interest from potential tenants, Gov. Rockefeller announced that 33 state agencies and departments would occupy space in the as-yet unbuilt Trade Center.

In July 1965, the Port Authority said that 75 percent of the space in the proposed Center was "reserved, committed or under active negotiation."

Since 60 percent of the space was already taken by governmental agencies, the statement really meant that only 1.5 million of the 10 million square feet of space 15 percent of the total was actually under serious consideration.

Citing a recent program on the World Trade Center broadcast by The History Channel, a cable network, Brody disputed the Port Authority's assertion that it paid full compensation to the evicted shopkeepers. "They didn't," he said. "They only paid for moving." He received \$3000, the maximum provided by the Port Authority as a moving allowance.

Rather than start anew, Irving Jaffe simply closed the doors of his store, East Radio, which he started at 74 Cortlandt St. in 1933. He went to work for another electronics retailer and never recovered from the ordeal of losing his business. For years afterward, "he was despondent," said his daughter Barbara, a New York photographer.

During the boom years of the 1950s, MacInnes had opened another restaurant, on Seventh Avenue across from Macy's. Having sold it in 1965, he had to move from his original Cortlandt Street location when the Port Authority came to evict him in the early spring of 1967. With the customers who braved the trenches, the bulldozers and the jackhammers to partake of his plain old food, MacInnes relocated to 33 Cortlandt St. that May. "I put on a tam o'shanter, hired a bagpiper, and led a parade of customers and opened up the bar," he said. Despite the auspicious opening, he closed after a year.

Janet Webb is still angry about her father's ordeal. "We were all getting to be about college age," she said of herself, her brother and her two sisters, "and they took his livelihood away."

Faced with that loss, he and his wife, Virginia went into the real estate business. They started Terrace Realty in Forest Hills in 1968 and built it into a successful brokerage before retiring for good in 1985. Their daughter and son-inlaw, Susanna and Robert Hof, now run the brokerage.

Herbert and Margaret Simonoff closed the last of their remaining New York area Leonard Radio outlets in 1990 and retired to the South. Though still angry over the forced loss of his original store and of Radio Row, Simonoff still remembers the area and the era fondly.

"It was a time and a way of life than can never happen again," he said.

Those who have been following the work of the Maritime Radio Historical Society (MRHS) know that what we now call the KPH transmitter site in Bolinas, CA was established by the American Marconi Company in 1913.

The objective was not marine communications but trans-Pacific point-to-point contact with the cities in the Pacific rim. The first transmitter at Building 1 in Bolinas was the standard Marconi Co. rotary spark gap. But when the Radio Corporation of America absorbed the assets of the American Marconi Co. after WWI they replaced the rotary with two Alexanderson alternators of 200kW each.

In his famous book "My San Francisco Story of the Waterfront and the Wireless" Richard Johnstone refers to the station as Bolinas High Power. And indeed it was. The long wave voice of these wonderful machines was heard across the ocean, day and night. When I arrived at the Bolinas site in 1972 I remember seeing a large copper plaque on the side of Building 1 proudly proclaiming that Alexanderson alternators dwelled within. The alternators were of course long gone by then. But on my second visit the plaque was gone. Only the threaded studs of its mounting remained, as they do today.

Since it was clear that the plaque had been carefully removed I hoped that it was in the hands of a collector who understood its importance. I hoped too that some day that plaque would surface and be returned to its home. That day happened when an email arrived from Steve Kushman of the California Historical Radio Society. He informed me that the plaque was in the possession of History San Jose museum. Monica Tucker of that museum graciously offered the plaque to the MRHS.

Today it was delivered to my San Francisco office. It will soon be back at the Bolinas transmitter site... excuse me, at Bolinas High Power. The plaque measures 3ft x 2ft and is massively heavy. It took two of us to move it from the delivery vehicle to my office. The inscription reads: This Station Was Designed and Constructed by the Radio Corporation of America. The 200 K.W. High Frequency Alexanderson Generating Equipment was Manufactured and Installed By the General Electric Company. The General Engineering and Construction work was performed by the J.C. White Engineering Corporation 1920. Clearly, this was a time when people and corporations were proud of what they did and wanted the world to know of their works.
